Scoring - Pool Play:

3-Team Pool: 3 sets to 25 points, with the score **starting at 7 points.** Higher seeded team will serve first.

4-Team Pool: 2 sets to 25 points, with the score **starting at 7 points.** Higher seeded team will serve first.

All Teams will advance to a single elimination tournament. Teams will be seeded 1–7 based on their finish in Pool Play.

The top 4 seeded teams will advance to a single elimination Championship Bracket.

The next 3 seeded teams will advance to a single elimination Consolation Bracket.

Awards will be given to the champions of the **Gold** Tournament only.

Scoring - Tournament Play: (Coin flip for serve)

All matches are 2 out of 3 sets to 25 points, with the score **starting at 7 points.**

A Third game (if necessary) will be played to 15 points, with the **score starting at zero (0).**

Warm-Ups: No shared hitting time

2 minutes of shared court time.

4 minutes of court time for the serving team.

4 minutes of court time for the receiving team.

Warm-ups will be reduced to 1/2/2 minutes after each team has played one match.
