The following policies apply to all tournament participants and spectators. These policies will be strictly enforced by The Courts management and the The Courts VBC.

Outside Food and Beverages:

No coolers or outside food and drink will be allowed inside The Courts Volleyball Training Facility. This policy will be strictly enforced! A water bottle/sports drink bottle for players is permitted. The Courts will have a wide variety of reasonably priced food and beverages available at our concession stand.

Equipment:

For Coaches/Teams: Please **DO NOT** bring volleyballs and carts into The Courts Volleyball Training Facility. The Courts will provide warm-up volleyballs and carts for each court. Coaches who bring balls and carts into The Courts will be asked to return them to their cars.

Player Camping Area:

ALL players must take their bags to the designated area of the facility. No bags/teams will be allowed to camp in the spectator seating areas. Players and coaches are asked to keep trash picked up during the day and before leaving for the facility. Thank you for your help

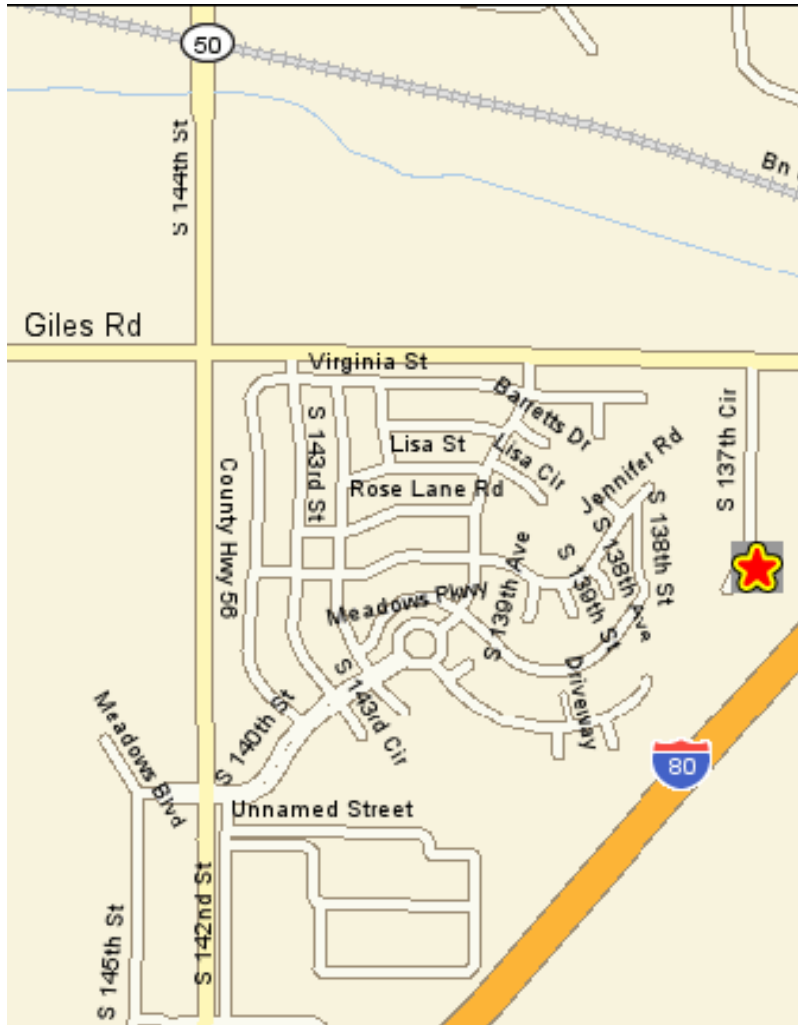
Chairs:

DIRECTIONS:

Eastbound Interstate 80 – Take 144th Street (Hwy 50) also referred to as the “Sapp Bros” Exit. Turn Left (north) on 144th St. (Hwy 50). Travel for less than one mile to Giles Road. Turn right onto Giles Road and proceed a half mile to 137TH Circle. Turn right on 137th Circle. Follow 137th Circle to the end of the Circle. The Courts is located in the last building on the left side. Main entrance faces I-80.

Westbound Interstate 80 – Take 144th Street (Hwy 50) also referred to as the “Sapp Bros” Exit. Turn Right (north) on 144th St. (Hwy 50). Travel north for less than one mile to Giles Road. Turn right onto Giles Road and proceed a half mile to 137th Circle. Turn right on 137th Circle. Follow 137th Circle to the end of the Circle. The Courts is located in the last building on the left side. Main entrance faces I-80.

From Millard – Take 144th Street (Hwy 50) to Giles Road. Turn left onto Giles Road and proceed a half mile to 137TH Circle. Turn right on 137th Circle. Follow 137th Circle to the end of the Circle. The Courts is located in the last building on the left side. Main entrance faces I-80.
