(number of sets won divided by number of sets played)
5. TOTAL POINT DIFFERENTIAL

Criteria 1-4 may be used to eliminate a team from the Gold tournament. Point Differential may not be used. If three teams are tied, including set %, then a 1-set playoff to 25 between the 2nd and 3rd team will be played to determine the advancing team.
